### **Necessary Processing**

#### **Legal Basis for Processing**

In accordance with sections 29 & 30 of the Localism Act 2011, the Monitoring Officer is required to establish and maintain a register of interests, to ensure that it is available for inspection and that it is published on the authority's website, and you are required to notify the Monitoring Officer of the information in sections 1 to 7 of this form.

Our processing of this information is therefore necessary for the performance of a task carried out in the public interest, specifically for discharging our duties under Sections 29 & 30 of the Localism Act 2011. If your data includes special category data, the processing is necessary for reasons of substantial public interest, namely for the proper discharge of our statutory duties mentioned above, and is necessary for reasons of substantial public interest (promoting and maintaining high standards of conduct by our elected Members), and we have an appropriate policy document in place.

#### **How Your Data Will Be Processed**

We will process your personal data for the purpose of maintaining a register of interests of Members of the Council, including securing that a copy of the register is available for inspection at the Civic Hall, Leeds at all reasonable hours, and that the register is published on the Council's website.

In accordance with Section 32 Localism Act 2011, the Monitoring Officer will maintain a record of any interest which she has agreed should be treated as a sensitive interest but this information will not be available for public inspection or published to the Council's website.

We will store your data until you cease to be an elected Member. Information relating to an interest which you cease to have will be stored by the Monitoring Officer (but not available to the public) for a period of 3 years.

#### **Who Your Data Will be Shared With**

The recipients of your personal data are members of the public generally.

#### **Your Rights**

You<sup>12</sup> have the right to request from us, access to and rectification or erasure of your data, or restriction of processing, or to object to processing as well as the right to data portability. You have the right to complain to the Information Commissioner's Office.

#### **Processing by Consent**
